





SUBJECT: OC Court Watch Protest

On July 19, 2016 I received notification that a protest was planned in front of the OC Superior Court in Santa Ana on Friday, July 22, 2016 from 0800 hours to 1200 hours. The protest is entitled OC Court Watch and the goal is to demand accountability in the criminal justice system. They will also be protesting the officer involved shooting deaths of Manual Diaz and Joel Aceveda. It should be noted those incidents occurred on July 21<sup>st</sup> and July 22<sup>nd</sup>, 2012 and this will be the four year anniversary.

Last night the group held a training session in Santa Ana from 6-7:30 to educate anyone about the issues that they are protesting; The misuse of Brady Information and Informants. It appears that this training was put on by ACLU. It is unknown how many people attended the training.

I contacted Crime Analyst Iris Huang to conduct an open source search for additional information regarding this event.

The following Organizations are Co- Sponsoring this event:

I have researched the above Organizations and summarized them below:

# <u>ACLU</u>

Americans Civil Liberties Union- Law professional Group that works to defend and preserve the individual rights and liberties guaranteed by the Constitution and laws of the United States. This group does not advocate violence, instead chooses to take their causes to the courtroom.

# Angels For Justice

Is a nonprofit film company that creates films around socially conscious issues. Their latest film is regarding Wall Street Corruption, child trafficking and same sex relationships. I did not see anti law enforcement postings on their website, but it is quite possible that will be their next project and they will be filming this event.

# Arthur Carmona Center for the Wrongly Convicted

This organization developed from Arthur Carmona who was allegedly wrongly arrested by Costa Mesa PD and allegedly wrongly prosecuted by our office. While charges were dropped two years after his initial arrest at 16 years of age, our office did not admit wrong-doing. His family blames the change they saw in their son after his release, on the two years he was incarcerated. This organization fights for wrongly convicted individuals. They are well organized and have a national following. They are one of ACLU's partners. There website does not advocate violence.

# Chicanos Unidos

Chicanos Unidos is a social activist group combatting concerns in predominantly Hispanic communities. This includes gang injunctions, immigration, and any police actions, especially in Santa Ana. Gaby Hernandez and Caroline Torres are vocal in the Santa Ana communities and they work with the families of Joel Acevedo and Manuel Diaz at community events. Community members who attend their events are vocal and try to provoke law enforcement. But I have not been notified nor witnessed violence. Videos and photos are taken of law enforcement at events and posted on social media. They often spin events negatively to fit their agenda.

# CJ Ford Investigations

CJ Ford has been a private investigator since 1988. His passion is pro per defendants and making sure their rights are preserved during the court process. He believes that he was unjustly removed from the Alternate Defendants PI list and subsequently wrote a book entitled, "Whistle Blowing Orange County Style." He blames Judge Robison for the injustices he has suffered and has published numerous court documents about his case. I did not see any violence advocated on his site.

# Youth Power OC

Youth Power OC is the newest group on this list, forming last summer. The goal of this group is to develop an autonomous vehicle for OC's youth of color to organize at the forefront of issues. They went to Sacramento last year to bring awareness to their issues. Photos of their website indicate that primary membership appears to be Hispanic and it does appear they are still in the recruitment stage for their group.

# Individuals of Interest

<u>Renee Balenti</u>- Advocates the Abolition of Police Departments. She wants private citizens to police society. She believes that all police are corrupt and often attends functions sponsored by our office in an Anonymous mask. She advocates filming any and all contacts with police. She is very involved with the families of Manual Diaz and Joel Acevedo and advertised a memorial set up on Anna Drive at 5 pm Thursday, July 21<sup>st</sup>.

It is very likely that Balenti and her husband will be at this protest.

# Patti Beers-

Vocal advocate for Kelly Thomas and was very involved in the protests of Fullerton PD. She is close friends with Renee Balenti and she claims she is a member of the press. At the moment, it appears she is in Los Angeles assisting in the Black Lives Matter protests at City Hall. She often live streams from their locations. I do not see any postings regarding the OC Protest on her social media and feel her interests are in LA this week.

Genevieve Huizar – Manual Diaz's Mother. Genevieve Huizar is a leader in The Young Survivors Network, which advocates efforts to end police violence. She is very vocal regarding her hatred and contempt for police as she alleges that her son was murdered by Anaheim Police Department in 2012. She has spoken about her contempt at many community events throughout the state and advocates for police accountability and more training for officers. She was present during hearing for the Kelly Thomas case and is present at many Santa Ana city council meetings and some injunction hearings. She attempts to provoke law enforcement verbally at events.

I expect her to attend the protest on Friday.

<u>Donna Acevedo</u>- Joel Acevedo's Mother is not as active as Genevieve Huizar, but does attend some meetings with her. She also alleges that Anaheim Police Department unjustly killed her son in 2012.

Since this event is partly in honor of her son, I expect her to be there on Friday.

Currently, on July 20, 2016 at 1030 hours 41 people have posted on Facebook that they will be attending the protest and 101 people have indicated they are interested in attending.

- Deny Access
- Use busy streets do not take short cuts
- Walk in the center of sidewalk

- Take the Elevator, not Stairs

- Throw the property in opposite direction and run

- Request an escort to your car or walk in a group
- Have keys in your hand
- Observe surroundings:
- As soon as possible, lock doors & drive away

## Prevent Assault – Take Action!

- If approached take action!
- Decide
- Run
- Scream
- Take action
- Do anything to draw attention
- Do not be taken from the scene!

### If Attacker is Armed

- Knife try to stay out of arm's length
- Gun consider running and dodging from left to right (zigzag)
- Give the attacker your wallet or belongings
- Toss wallet or belongings away from you and run

## **Jse a Defensive Posture**

- Stand upright with a wide base
- Keep your feet diagonal from each other in a martial-arts stance
- Go for the eyes and nose; use elbows, knees and your forehead
- Kick, grab, or knee the groin of a male attacker
- End the fight as quickly as possible
- Strike first
- Strike hard
- Strike as many times as you can
- Run for help!



Good Afternoon.

This morning threatening graffiti "187 on a cop" was discovered on the west side of the CXC (civil court on the corner of Santa Ana Blvd and Flower). Deputy Beckley has written DR #16-147095, taken photos and informed OCIAC. Deputy Beckley also reviewed the OC Superior Court CCTV system. At approximately 0230 hours a subject, possibly female, can be seen walking away from the location with what appears to be a spray paint can. There was also several other acts of graffiti in the area of the civic center, "KKK" on concrete sign at entrance to court parking lot. Sergeant Hylton has talked to SAPD civic center officer and informed them of the graffiti. SAPD watch commander (Corporal Verdugo) has been notified via telephone. Santa Ana PD was unaware of the vandalism. Deputy Beckley is working with OCIAC and SAPD to help ID the suspect through the moniker.

OC Superior Courts Facilities staff is currently working with the county Public Works and the City of Santa Ana to get the graffiti removed.

Sgt. Hylton is also contacting your operation sergeants to pass the information along.

Advisory memo is attached if you could pass the information along to your staff at briefings, to be aware of their surroundings in the civic center area.



### Situational Awareness


On Thursday, June 16, 2016, around 0730 hours, a County of Orange, Civic Center sign was discovered spray painted with "KKK." The sign is located at the intersection of Flower and 6<sup>th</sup> St. on the southeast corner of the intersection. The vandalism was removed and the Sheriff's Department made notifications to the Orange County Intelligence Assessment Center (OCIAC). A report was generated by the Sheriff's Department.





At approximate 1200 hours, more graffiti of the same color and style was located on the east side of the Orange County Superior Court Civic Complex Building located at the corner of Flower and Santa Ana Blvd. "187 on a cop" was sprayed on a west facing wall along Flower St. At approximately 0229 hours, an unknown subject (possibly female) can be seen walking from the area where the graffiti was discovered.

Be mindful of your surroundings while walking in the area.
