**PROCEEDINGS (IN CHAMBERS): ORDER SETTING STATUS  
CONFERENCE**

The Court ORDERS all parties to appear for a hearing on **April 3, 2018, at 9 a.m.** to discuss, among other topics, the status of and plan for those persons who were removed from the Riverbed and housed in motels or shelters for thirty days. *See, e.g.,* Stipulation Between the Parties (Dkt. 92) (“At the conclusion of the 30 day period, appropriate resources . . . will be provided.”). Based on information received during status conferences, the Court is growing increasingly concerned about whether the County has a sufficient number of beds for the hundreds of individuals exiting from motels over the next week. The County had thirty days to create a plan for transitioning those individuals to appropriate placements, and the Court expects the County to live up to its stipulation, and to address this issue before the April 3rd status conference if needed.

In addition, the Court is interested in hearing at the status conference whether and how the County and/or cities decided to resolve the need for a proportional distribution of shelter availability, in order to address homelessness throughout the three different mental health service zones in the County. The Court anticipates, based on the prior representations of the parties, that the County will coordinate with cities in the selection
