The Court appreciates the work of Orange County Sheriff Don Barnes in promptly examining and seeking to address the death toll of homeless individuals in Orange County.

In light of ongoing settlement negotiations and to understand the nature of the public health crisis in the County leading to the deaths of hundreds of people experiencing homelessness, the Court REQUESTS that the Orange County Sheriff's Department provide the causes of death of the homeless individuals who passed away in Orange County in 2018 and 2019.
