GOLDEN STAR TECHNOLOGY INC	6,797,468	This vendor is the main supplier of information technology equipment to HCA. Items purchased from GST support a variety of HCA COVID-response activity. Laptops, computers, monitors and docking stations were purchased to support teleworking for the safety of our staff. In addition, webcams were purchased for our medical professionals to conduct telemedicine. Servers were also procured from GST to support applications and software for COVID testing and research.
Goforth & Marti	4,922,397	GoForth & Marti supplied equipment and installation services for workplace modifications to comply with social distancing guidelines. Modifications include installation of plexi-glass in public facing locations and worksite cubicles, and the reconfiguration of cubicles and offices.
360 HEALTH PLAN INC	4,177,734	360 Health Plan provided COVID-19 testing to the residents of Orange County, which included coordinating daily operations at test sites, administering PCR-tests, specimen submission to a County-approved laboratory, communicating patient results, and collection of patient insurance or identification for possible reimbursement.
AM TRACE LLC	3,829,566	AM Trace provided case investigation of COVID positive cases and contact tracing to identify possible contacts, who were educated on self-quarantining and self-monitoring of medical symptoms. In addition, the vendor provided data for analytics and a training plan for County and contractor staff.
